CLAIM FOR SETTLEMENT BENEFITS

Instructions: Please read these instructions carefully before submitting this form.

This Claim Form is for persons who believe they are entitled to participate in the *MNP* Class settlement, but whose names are not reflected on the Tax Collector’s records as having redeemed property that was sold at a tax sale. To determine whether the Tax Collector’s records reflect your name as an *MNP* Class Member, you should contact class counsel, whose names and addresses are set out below. Or you should visit the web site www.jeffcotaxpayers.com.

Checks for Net Distributions will automatically be sent approximately 90 days after final approval of the settlement to those Class Members who can be identified through the records of the Tax Collector, unless some other person files a claim pertaining to a putative class member’s parcel. All disputes over who is entitled to a Net Distribution will be submitted to the Judge for resolution. If you are not listed on the Tax Collector’s records as having redeemed a parcel sold at a tax sale for an overbid and if you believe that you are entitled to participate in the settlement, you should file a claim no later than **May 5, 2008.**

If you believe that you are entitled to participate in the settlement and your name is not reflected on the Jefferson County Tax Collector’s records as a member of the *MNP* Class, you must file a claim no later than **May 5, 2008**. To file a claim, you must fill out and sign a Claim Form and file the completed Claim Form in the Jefferson County Circuit Court Clerk’s Office, whose address is below. You must also mail copies of your claim (with all attachments) to Class Counsel, whose addresses are set out below.
